For a brief moment I felt a flutter of anxiety - until I clicked on the article and began to read. It turns out that ongoing supply chain woes are threatening the availability of Christmas presents. And then I thought, "Is that really such a bad thing?"

As we enter November, the holiday season is right around the corner. If you go into retail stores, it's already here. Every year we get pressured to buy more than we need, spend more than we have, and at the end of it all, Christmas comes and goes and we're left stressed out and in debt. Perhaps this disruption to our usual holiday gift-giving frenzy is a lifeline permission to "opt out" of the Christmas that was never really Christmas in the first place.


The season of Advent begins at the end of this month, and it invites us to reflect on and prepare for the Christmas that cannot be taken away: the miracle of God with us - heaven meeting earth in the frame of a tiny infant. Some 2000 years ago, God proved that not even an unplanned pregnancy and a community's whispers, nor a lack of suitable lodging, nor a murderous king could thwart God's plan. This year, as we face another holiday season with COVID in

the background, pumpkin pie shortages in the grocery stores, and news of supply chain issues and shipping delays, we could benefit from that reminder. That's why, on November 28, we'll be starting our Advent worship series, "The Heart that Grew Three Sizes," which is based on Dr. Seuss's *How the Grinch Stole Christmas*. Those of us who've read or watched the Grinch's story know that Dr. Seuss's title is misleading. In the end, the Grinch didn't actually steal Christmas, because he *couldn't* steal Christmas. Not the true Christmas, anyway. So mark your calendars, plan to join us, and invite a friend or a neighbor to come and experience the Christmas that can't be taken away.

Dears,

Greetings in the mighty name of our Lord and Savior Jesus Christ. May grace and peace be given unto you from above. Amen! We always give thanks to God for your lives and the multiform support that you lend us in our ministry.

We are doing fine despite all the problems and hardships caused by the COVID pandemic. Mbwizu and I are fully vaccinated, but statistics show that only 36% of the population is fully vaccinated in Belize where we are. Many people resist vaccination, putting thus others on risk.

The government has closed all churches, for the third time since the break out of the disease in March 2020. We have been allowed to reopen this week, but only vaccinated people can attend worship service. The government has issued a regulation (they call it: **Statutory Instrument** 'SI') that if police officers come to a church and find people who are not vaccinated, the pastor will be fined. This is a very challenging and embarrassing situation. Churches cannot discriminate people based on their health status. But at the same time churches must not put lives of people in jeopardy because of those who refuse deliberately to take a vaccine. It puts me as a minister a difficult position.

As a pastor in charge of 3 congregations, I have come up with an alternative: **online service on Facebook**: the preacher, the liturgist and those who do prayers, readings and announcements connect on Zoom; then everything is broadcasted on Facebook for members to watch on live streaming. While this helps everyone to stay at home and have the opportunity to worship far from being in contact with other people, it has also its own negative aspects: 1) we miss the direct fellowship with brothers an sisters; 2) only a few members of our church in this part of the world have android phones or tablets that can allow them to connect on Facebook; 3) Sunday offerings are dropping significantly and makes it difficult for the church to pay its bills and honor other financial responsibilities.

We appreciate your prayers and any kind of support for us and the ministry that God has called us to do in this part of the world.
